
Tresident's Message



A 9/11 Story -- ROSELLE'S FINEST HOUR

(FROM THE READER'S DIGEST)

The morning of September 11th, 2001, computer sales manager Michael Hingson, who is blind, arrived early at his office on the 78th. floor, North Tower, World Trade Center, to prepare for a meeting. As he worked, his guide dog, Roselle,

a Labrador retriever, dozed at his feet.

At 8:46 a.m., a tremendous boom rocked the building, eliciting screams throughout the floor. Michael grabbed Roselle's harness trusting that the dog would lead him out of danger, & they navigated toward the stairwell. "Forward," Michael instructed, & they descended the first of 1,463 steps to the lobby. After 10 floors, the fumes from the jet fuel made it hard to breathe. When a wom-

HOLLYBROOK GOING FORWARD

Hello to all who call Hollybrook home...I hope that you are enjoying the summer months whether you are here in South Florida sweating it out with us or if you have retreated to cooler climes for a while. From my perspective as we approach a year since the change to the Hollybrook organization that created my position, I would like to state that I truly see this as a generational time for this community. Whether it is my day to day interaction with residents, in the context of Board level discussions and meetings, or in my ongoing engagement with hard working groups such as the Strategic Planning or Restaurant Search Committees, there is a new vibrancy in the air around the property. It is my hope that all will embrace this new mindset as I believe that every unit owner stands to gain from the changes that we are working toward, both in the short -and- long term.

Over the next 2 months in this column I would like to offer two high visibility examples of this new approach that Hollybrook stands poised to capitalize on. This month's example is the recent selection of Alan Goodman and his dynamic team of highly experienced food service professionals to run our restaurant. We are on track to re-open the restaurant under his management in early September and

we are working very closely with him to get the restaurant fully ready for the resumption of operations and the upcoming winter season. As many of you know, Hollybrook utilized the services of a company called Restaurant Placement Group (a headhunter firm) to assist the search committee in the identification and vetting of potential operators for our restaurant. Due largely to that company's tireless efforts on our behalf, we have been rewarded with a restaurateur who has the vision to take food and beverage operations throughout Hollybrook in a myriad of new directions that can realistically turn the Hollybrook Restaurant into a self-sustaining operation. I do not believe it is an overstatement on my part when I say that if the relationship between Hollybrook and Mr. Goodman does not work out it will not be a result of his efforts to run our dining room and catering operations failing short. It will in all probability be because Hollybrook has impeded his ability to conduct his business in an efficient and market driven manner. And note that I did say "his business." This is an aspect of the Hollybrook Restaurant dynamic that too often gets downplayed -or- outright ignored.

They say that a rising tide lifts all boats and the restaurant

under Mr. Goodman's direction can be that tide within our community. The challenge to the rest of us is to embrace the success of the restaurant and not see the relationship between Hollybrook and the people who have stepped in to operate it as an adversarial one. We should expect to see shortly that the success of the restaurant is a significant driver in the overall tenor of this community at large. I pledge to do my part to facilitate the success of the restaurant within the bounds of the authority vested in my position and subject to budgetary constraints that operate in this and all other areas of our management of Hollybrook. I challenge the residents of Hollybrook to join me in pledging to do their part to enable the profitability and sustainability of this newly revitalized restaurant venture right from the start.

Next month I will speak to the changing budgetary/financial environment at Hollybrook and what is in store over the next 7-8 months due to the upcoming change to our fiscal year and the transition to a new reserve funding model to be fully engrained in our budget process going forward. I look forward to communicating with you again then, if I don't see you around the property in the meantime. Thank you for your time.

This lease will be for a 54 months with a monthly payment of \$10,115.00. To be funded from Schedule "C" of the 2015 budget which has an allocated amount of \$158,000.00. Motion Seconded by. After a discussion a vote was taken, Motion "C" passed unanimously 20 to 0 (R. Labate joined the meeting)


an became hysterical, Roselle nudged her until she petted him, calming herself.

Around the 30th floor, firefighters began passing them, each one offering Michael assistance, he declined, but allowed them to pet Roselle...their last act of unconditional love.

An hour later, after reaching the lobby, the police began to yell that the South Tower was falling.

Hours later, Michael & Roselle made it home safely.

In the months to follow, Michael became a spokesperson for Guide Dogs for the Blind, the organization that trained Roselle. Together they spread their message about trust & teamwork. In 2007, Roselle retired from guiding & touring. "I've had many dogs," Michael wrote, "But there was only one Roselle."



COOKING

To most people, Labor Day means the end of summer—and that's the way it's been celebrated since 1893! We all want to enjoy the last summer weekend by relaxing, spending time with family and friends, not worrying about work, and most of all, EATING! Who could ask for a better holiday?

BASIL AND SUN DRIED TOMATO CRESCENTS

2 tubes (8 ounces each) refrigerated crescent rolls

2/3 cup butter, softened

1/2 cup minced fresh basil

1/4 cup oil-packed sun-dried tomatoes, patted dry and finely chopped

1 teaspoon garlic powder

Preheat oven to 375 degrees. Unroll each tube of crescent dough; separate dough into eight triangles. Roll up and place

2 in. apart on baking sheets, point side down; curve to form crescents. Bake 11-13 minutes or until rolls are golden brown. Makes: 16 rolls.

FISH SOUP

1 can Progresso New England Clam Chowder

1 can Geisha whole clams

1/2 pound shrimp - heads off

1/2 pound fileted fish, cod, snapper, grouper, mahi or sole (not tilapia or catfish)

1/2 pint of half and half cream

1 large onion (larger than a golf ball, smaller than a hardball)

3 ounces white wine

3 tablespoons of fresh chopped parsley

1/4 teaspoon basil

1/4 teaspoon paprika 1/4 teaspoon oregano

2 tablespoons butter

Melt butter, saute the onions until they begin to soften. Cut the fish fillets in 1 inch squares and the shrimp in half and sprinkle Old Bay Seasoning on both. Add fish and shimp to the onions, add a little more butter if the onions absorbed it all. Saute the mixture until the shrimp are cooked, about 4-5 minutes. Add the clams, wine, 3 spices and parsley and stir over high heat.

Then add the cream and chowder and stir, add ground pepper to taste. Bring the heat down to a simmer and cook for at least 15 minutes. Don't cook for more that 25 minutes. Makes: 4 servings.

CHICKEN WITH CHERRY PINEAPPLE SAUCE

3 boneless skinless chicken breast halves (4 ounces each)

1/2 teaspoon garlic salt

1/4 teaspoon ground ginger

2 teaspoons canola oil

1 can (8 ounces) unsweetened pineapple chunks 1/2 cup sweet-and-sour sauce

1/4 cup dried cherries

2 green onions, sliced

Spinkle chicken with garlic salt and ginger. In a large nonstick skillet coated with cooking spray, brown chicken with oil. Drain pineapple, reserving 1/4 cup juice. In a small bowl, combine the sauce, cherries and reserved juice; pour over chicken. Bring to a boil. Reduce heat;

My Bridge and Yours

In these articles, we bid and play a deal, and you hear my thoughts. You won't agree with all of my actions because bridge is a game of style and judgment. My off-the-cuff analysis may be imperfect. That, too, is part of the game. Still, I hope you'll find it helpful to follow my thinking during a deal.

In a regional knockout teams, both sides are vulnerable, and as South I hold a promising hand:

♠AKJ82 **♥**AJ3 **♦**K83 **♣**A2.

I'm in third seat and hear two passes. I could describe my strength and pattern with a 2NT opening, but I am never eager to crowd my own auction, and 2NT is a space-consuming action. Because I am also reluctant to suppress a good five-card major, I open 1 . If my partner would have responded to 2NT, maybe he will respond to 1 .

West, at my left, jumps to 3., preemptive, and my partner cuebids 4. He should have spade support, a maximum pass and a control in clubs. In that case, I can't see bidding less than 6., and even a grand slam is possible. Partner might hold:

AQ1074 ♥872 ◆AQJ65 ♣6.

I start the search with a 4 ♥ control bid, and partner makes a 5 ♦ control bid in reply. He must like his hand – I wouldn't expect him to go past game for a control bid unless he had real slam aspirations – so I continue with 6 ♣, and partner bids 6 ♥. I can't count 13 tricks – we may have a diamond

loser - so I sign off at 6 ♠, and everyone passes.

West leads the *K.

- ♠ Q10976
- ♥ K42
- ♦ AJ92
- **4** 5
- AKJ82
- ♥ AJ3
- ♦ K83
- + A2

We had a reasonable auction and stayed out of an iffy grand slam. Indeed, I haven't made 6 \$\text{ yet. I take the \$\text{\$\text{\$\text{\$A}\$}}. ruff my other club in dummy and draw trumps with the ace and queen, finding West with a singleton. Now it looks to be a matter of trying red-suit finesses and hoping something good happens. To attack diamonds first is correct because the suit may produce three tricks even if a finesse with the jack loses. I could play as safely as possible for three diamond tricks: ♦ A, ♦ K, then a third diamond toward the jack. But I doubt that West would hold four diamonds after his vulnerable club preempt.


Is there anything better?

My mind's eye is drawn to those diamond spots. Partner's ◆ 9 - an unbiddable value - would make 7 ♠ a little better contract, but at 6 ♠ it gives me a sure thing. I lead the ◆ J from dummy, intending to pass it if East plays low. If West has the queen, I won't mind. He will have to lead a club, conceding a fatal ruff-sluff, or lead a red suit, giving

me a free finesse.

As it happens, East covers the ◆ J.

I take the king and play the ◆ A and a third diamond, making dummy's 9 high for the 12th trick. A different line of play might have failed because the full deal is this:



At the other table, South opened 2NT, and West passed. When North transferred to spades with a 3 ♥ response, South jumped to 4 ♠, perhaps unwisely. That lit a fire under North, who not unreasonably unleashed a key-card ask. When he found South with the four missing key cards, he roared into 7 ♠.

That would have been a winning contract if South had held something more in line with his super-acceptance of the transfer, such as:

♦AK852 **♥**AQ3 **♦**K8 **♣**AJ2.

As it was, declarer needed a winning diamond finesse plus a little more, and when East turned up with the







HOLLYBROOK HURRICANE DISASTER PLAN

Evacuation and Transportation for Hollybrook Residents

MITCH DAVIS – Director of Facilities

CARL MACK – Co-Chairmen

Upon notification of evacuation, the Red Cross will open hurricane refuges for those without a safe place of shelter, approximately four (4) hours after official evacuation order is issued.

EVACUATION IN HOLLYBROOK WILL PROCEED AS FOLLOWS:

- 1. Building Captains will be notified through Manager's Office to advise all residents in their building to assemble at exterior of building with prepared items, most likely needed.
- 2. Recommended items most likely needed as follows:
 - (a) Easy to carry canvas bag.
 - (b) Clothing and bedding.

One complete change of clothing and footwear per person. Blankets or sleeping bag.

(c) Food (3-day supply)

Alcoholic beverages not permitted. Ready-to-eat canned meats, fruits, fish and vegetables.

Smoked or dried meats.

Juices—canned, powdered or crystallized.

Soups—dried "soups in cup." Milk—canned or powdered.

High energy foods—peanut butter, jelly, crackers, nuts.

Stress foods—sugar cookies, hard candy, sweetened cereals.

Water—unbreakable containers.

(d) Other items—

Non-electric can opener and utility knife.

Battery radio, flashlight and plenty of batteries.

Paper cups and plates and plastic utensils.

Toilet tissue and towelettes.

Personal hygiene items.

Plastic garbage bags.

HURRICANE PREPARATION

HURRICANE PREPARATIONS FOR HOLLYBROOK RESIDENTS SEASON JUNE 1 TO NOV. 30TH

SEASON JUNE 1 TO NOV. 30TH

Pay attention to local official announcements on radio and television from the National Hurricane Center and local officials.

HURRICANE WATCH—is issued for a coastal area when there is a threat of hurricane conditions, generally within 36 hours.

HURRICANE WARNING—is issued when hurricane conditions are expected in a specified coastal area in 24 hours or less. Hurricane conditions include sustained winds of 74 miles per hour (64 knots) and/or dangerously high tides and waves. Actions to protect life and property should be rushed to completion after the warning is issued.

PREPARATIONS BEFORE THE STORM:

- 1. Prepare two (2) week supply of non-perishable food. Select foods that require no refrigeration or preparation.
- (a) Canned meats, fruits, fish, vegetables, powdered milk or juices, canned or powdered.
- (b) Smoked or dried meats, dried "soups in cup."
- (c) High energy foods—peanut butter, jelly, crackers, nuts, health food bars, trail mix.
- (d) Stress foods—sugar cookies, hard candy, sweetened cereals.
- (e) Vitamins, plastic containers of water, prescription medications.
- 2. First-aid kit, paper cups and plastic utensils, non-electric can opener and utility knife, hurricane lantern and fluid, battery powered radio and flash lights with plenty of extra batteries, toilet tissue, paper towels, plastic garbage bags. Sterilize bath tub with bleach and rinse. Fill bath tub with water for back-up and flushing commode. Boil tap water before drinking unless advised otherwise by officials, store heavy plastic to cover possible broken windows,

move unanchored objects from patio inside of apartment, secure hurricane shutters. Learn in advance to shut off main valve for water and electric service in breaker panel if necessary. Take ill persons to a place where they can receive medical care. Place rolled up newspapers on interior window sills and doors to absorb possible storm water. Make arrangements to move your pets to a safe area. Do not use elevator. Turn your refrigerator and freezer to cooler settings in case power fails. Do not stock freezer with a volume of perishable goods. Stay away from windows. Be alert for tornados that sometimes accompany hurricanes. Remain indoors until official "All Clear" is given from the National Hurricane Center and local officials.

"COUNTY WARNING"

The county will use the emergency broadcasting system to issue instructions over the local T.V. and radio stations. Listen for specific Broward County informations.

You will have a better chance of survival, if you adhere to the foregoing preparations and warnings.

TORNADO SAFETY RULES WHEN A TORNADO APPROACHES, YOUR IMMEDIATE AREA

In cities or town:

Seek inside shelter, preferably in a steel-framed or reinforced concrete building of substantial construction.

Do not remain in a trailer or mobile home if a tornado is approaching; take cover elsewhere.

In open country:

If there is no time to escape, lie flat in the nearest depression such as a ditch or ravine.

If refuges are required, same procedure will be implemented as for hurricane.

Stay away from windows.

In office buildings:

Stand in an interior hallway or on a lower floor, preferably in a basement.

In homes:

In a house or apartment with no basement, take cover under heavy furniture in the center part of the house or apartment.

As a last resort, go outside to a nearby ditch, evacuation or culvert.



It's been busy around the City and there are many stories to share. We were happy to learn that the National League of Cities awarded us with a "Bronze Medal in Goal III: Smart Servings for Students" for establishing an active collaboration involving the city, schools and other partners to expand access to programs that offer healthy food before, during and after the school day, and/or

over the summer months. This was part of the "Let's Move" initiative we began participating in last year.

We are also proud to be holding a Patriot Day Remembrance Ceremony on Friday, September 11, 2015, 8:30 a.m. to 10:00 a.m. at the Pembroke Pines City Center Memorial, 10300 Pines Boulevard, west of Pembroke Pines City Hall. The ceremony begins with the Presentation of Colors by the City of Pembroke Pines Police and Fire Department Honor Guards. It will also include guest speakers, community leaders and patriotic music featuring local school bands and area musicians. This event is free and open to the public. I encourage everyone to please come to the ceremony to remember all those who lost their lives on this tragic day.

Recently our city dedicated

172nd Avenue to honor the memory of a former Pembroke Pines resident, Marine Lance Corporal Patrick Xavier, Jr. who was killed in action on May 18, 2010 at the age of 24 in Afghanistan. His death and those of all the men and women serving in the military should give us all pause. So many lives have been and are being lost to ensure our freedom, and that of countries around the globe. Let us honor and remember them all for their brave sacrifice.

Security cameras are now in place to ensure that the Pembroke Pines 911 Memorial remains safe from vandals. This action was in response to vandalism that occurred to the Memorial earlier this year, which included spray painting part of the sculpture, and the tearing of a piece of steel from the commemorative sculpture that depicts the twisted girders and beams from the fallen World Trade Center. The City Commission voted to install the security devices/video cameras at the site, primarily funded through the city's non-profit 911 Memorial Foundation, to ensure nothing like that happens again.

Helpful Tax Saving Advice and Tips from Broward County Property Appraiser Lori Parrish

Dear Lori:

We just received our "Do Not Pay" proposed property tax notice from your office. What is the best way to contact your office as have a few questions regarding valuations and exemptions?

The Millers, Pompano Beach, FL (via email)

Beginning August 12, the Broward County Property Appraiser will begin mailing the 2015 "Truth-in-Millage" (TRIM) Notices to property owners on behalf of the various Broward County taxing authorities. Over 768,000 "TRIM" Notices will be sent, providing property owners with their 2015 property assessment information, exemptions, proposed tax amounts and proposed tax rates. These notices also inform property owners of their right to both appeal their property assessment and to attend their various taxing authority budget hearings regarding the proposed tax rates.

The Property Appraiser's Office <u>does not</u> set tax rates or collect taxes. If you wish to discuss the proposed tax rates or new fees or fee increases on your TRIM Notice, you should contact the County Commission, School Board, City Commission and other taxing authorities. The TRIM Notice will include phone numbers for each taxing authority, as well as the schedule of public budget hearings. Each taxing body is requires to hold two hearings before they set the tax rate. They welcome comments from taxpayers like you when setting their budgets and tax rates.

The Property Appraiser's Office determines the property's market value as of January 1 and grants exemptions to qualified applicants. If you believe the market value of your property is not what a buyer would reasonably paid for the property on January 1, 2015, you must contact our office or file a value petition with the Value Adjustment Board by the September 18, 2015 deadline. If you believe you may be eligible for an exemption you are not currently receiving you can still file of all 2015 exemption until September 18, 2015. You can call, e-mail or visit our office to discuss your property assessment. For residential properties, please call 954.357.6831 or email Scott Lewis at slewis@bcpa.net. For condo, co-op and timeshare properties, please call 954.357.6832 or email Maureen Morison at mmorrison@bcpa.net. For commercial properties, please call 954.357.6862 or email Vincent Clark at vclark@bcpa.net. For exemption questions and assistance, please call 954.357.6830 or email Kelly Brown at kbrown@bcpa.net. Or you can contact Property Appraiser Lori Parrish at 954.357.6900 or email me at lparrish@bcpa.net. You may visit our office located at 115 South Andrews Avenue, Room 111, Fort Lauderdale. Our office is opened weekdays from 7:00AM to 6:00PM. To better accommodate the schedules of working families, our office will be open on Saturday, August 29 and Saturday, September 12 from 8:30AM to 5:00PM.

If after speaking to one of our appraisers, you still disagree with our determination of market value, we will help you file an appeal directly with he Value Adjustment Board (VAB).
